




Wesley House Shelter Honored and Supported by Project W

The Wesley House Shelter was chosen as a Project W 2021 Project Grant Winner receiving \$30,000 in support. Project W, a project of The Community's Foundation, is a women's giving circle that harnesses the power of collective giving to address the needs of women in Delaware County. The Wesley House



Shelter is a key part of the County's Continuum of Care providing safe and healthy emergency shelter to families and single women. It remained open during the COVID-19 Pandemic. The Wesley House submitted an application to Project W for the grant and met virtually multiple times with members of Project W. The shelter was chosen as one of three finalists while a video presentation was sent to all

members of Project W to be voted on. At their virtual Annual Meeting on June 16th, the members selected the Wesley House Shelter for this honor. Edward T. Coleman, CAADC CEO, stated "We are proud to be recognized and supported by an amazing group of women that care so much about their community."

Congrats also to Mitzvah Circle Foundation and the Tyler Arboretum which also received \$15,000 grants.

Recent Development Activity

CAADC has been fortunate to receive the following private contributions from the community during the last quarter: **First Presbyterian Church in Springfield** supported the Life Center with a donation of \$930. **RE/MAX Main Line Charitable Foundation** supported our summer programs with a donation of \$1,000. **Marple Presbyterian Church** donated \$750 to support the Agency. CAADC Making Homes Safer with Lead Paint Hazard Control Program

Community Action Agency of Delaware County, Inc. (CAADC) is now accepting applications for the Lead-Based Paint Hazard Control Program. In this program, qualifying families who have a child age 5 or under may qualify for new windows and other repairs to help remediate lead paint hazards. Income eligibility guidelines do apply. Once an application is received, CAADC staff meets with the applicant to explain the program in detail and to discuss the hazard of lead-based paint in the home. Next, a lead audit is performed by a licensed firm. A report is prepared showing where lead paint exists in the home. CAADC then prepares a Scope of Work detailing the steps that will be taken to remove or reduce the lead to acceptable levels. This may include replacing doors and windows, installing new drywall, replacing trim and moldings, etc. When the renovations are complete, another lead audit is performed to be sure that all lead has been removed or reduced to acceptable levels. A copy of the final report along with educational materials related to lead hazards is then given to the family. All of the services are free if the family is determined eligible.

Edward T. Coleman, CAADC CEO, urges, "This program can make your home safer and keep your children healthy."
